2. Each couple will pay Rs.10000 (Rs.Ten thousand only) per month for 12 months.
3. At the time of registration , each couple will pay Rs.5000 as the registration fee which shall be adjusted against the first installment of Rs.10000/-.

7. The package will comprise of minimum 03 star hotel stay, breakfast, sightseeing and transfers. Dinner and Lunch is not included. If there is compulsory Gala dinner, peak season surcharges or other surcharges shall have to be paid by the member.
8. Accomodation shall be on twin share basis. No package shall be provided from Dec20 till Jan10.
9. After paying six installments, members can travel giving remaining amount in advance in terms of cash.
10. The monthly payment by all the members will have to be paid by the 5th of every month. If 5th is a holiday, then the same has to be paid on next working day. Delay of payment will attract a penalty of Rs.100 per day and they shall not be eligible for lucky draw. 11. The remaining 40 couples shall be given the travel package for Rs.1,20,000 as per the airfares and applicable hotel tariffs at the time of their travel. In no case the money shall be refunded in cash.

12 . A minimum 45days notice is required from the member prior to travel.

13. Get together shall be on contributory basis.

14.These packages do not include travel insurance and Visa charges. Grant of visa depends upon the documentation of the member and decision will be purely taken by concerned embassy / High Commission only.

15. In case the member discontinues the membership by not paying the installments, no paid payment shall be refunded

16. In case of any dispute Mr.Balwinder Singh Sudan Advocate will be the sole arbitrator, whose decision will be final and acceptable to both the parties. The fee of the arbitrator will be borne by the party who will initiate the complaint.

17. Travelling will be in economy class only.
